

## Terms and Conditions – Mullum Co-Op Survey Draw

1. Information on how to enter and prize details form part of these conditions of entry.

3. The competition commences at 09.00am EST on 15th June 2022 and closes at 12.00pm EST on 30 July 2022. The draw will take place at 12.00 EST on Monday 1 Aug 2022 at 1670 Coolamon Scenic Drive Mullumbimby 2482, Australia.
4. The winner will be notified by email or phone on or before Friday 5 August 2022. The winner may claim the prize by contacting Mullumbimby Rural Co-Operative Society Ltd.
5. The competition is only open to persons over 18 years of age who reside in and are permanently located in Australia or New Zealand (“Eligible Person”).
6. Employees and immediate families of Mullumbimby Rural Co-Operative Society Ltd, its related entities and its agencies associated with this competition, are ineligible.
7. The Mullumbimby Rural Co-Operative Society Ltd reserves the right to verify the validity of entries and reserves the right to disqualify any Eligible Person for tampering with the entry process or for submitting an entry which is not in accordance with these Terms & Conditions of Entry.
8. Every Eligible Person who receives an entry in the draw will have a chance to win.
9. An entry in the draw will only be allocated to an Eligible Person, if that person:
10. Completes all mandatory fields of the authorised online form and
11. Electronically submits its entry during the competition period.
12. An Eligible Person is only permitted a maximum of one entry in the draw.
