Thank you for your enquiry regarding joining the Mullumbimby Rural Co-operative Society Limited.

The cost to join is \$200.00 (the purchase of 200 x \$1 shares) and these shares will be repurchased should you cease to be a member.

The Mullum Co-Op is a Shareholder owned co-operative, therefore the profit made in any one financial year may be paid back to the Members by way of a rebate. Rebates are paid based on the amount a Member spends in the previous financial year.

**Active membership requirements:**

A member must each full financial year, purchase goods or services from the Mullum Co-Op to the value of at least \$100 to establish and maintain active membership of the Co-Op.

You will not lose any of these benefits by paying cash or EFTPOS for your goods and fuel at the time of purchase if you advise staff that you are a Member.

The Mullum Co-Op has an Autoserve which allows Members to obtain fuel 24 hours a day. Each Member is entitled to one fuel card free of charge, any additional cards are available at a cost of \$10.00 each. You will be issued with a PIN number to use after hours to obtain fuel from the Autoserve.

Our Trade Service Partner is Mullumbimby Tyre Service. Please let them know you are a Mullum Co-Op member when you book your work in.

Our normal credit terms are strictly NETT 30 DAYS from statement issue date. Please be prompt with payment. We are not a member of the BPay organisation however we do accept internet transfer payment of accounts or payment by credit/Eftpos card at the counter or cheque. We have engaged the services of EC Credit Control. Any cost/s incurred to recover any payments due, as per our trading terms, will be the responsibility of the Member entirely.

Statements are usually processed within the first week of the following month and emailed out at our earliest convenience.
